Information provided here will be shared with faculty in aggregate form; no information will be shared by individual name.
- Part 3: Confirmation of support from your congregation, denominational entity, or agency. Given the time away from your ministry for this study and the integral connection between course content and your leadership efforts in a particular ministry context, the partnership of the student, the particular ministry, and the program is a key component to successful and satisfying completion of the program.
